




### **RELATIVE INTENSITY vs. WAVELENGTH**



### **SPATIAL DISTRIBUTION**






### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**



### TAPE SPECIFICATIONS (units:mm)




### **REEL DIMENSION** (units: mm)
